## 2 INTRODUCTION

## 3 USER GUIDE

The following is a description of each column used in the overview table in section 4 below:

- (i) **Document ID:** Is the identification number of the document.
- (ii) **Document title:** Is the current name of the document.
- (iii) **Distribution:** There are three different distribution categories
  - a. Red which means no distribution of the document to external parties.
  - b. Yellow which means that distribution of the document to external parties could be considered.
  - c. Green which means unrestricted distribution of the document to external parties.
- (iv) **Status:** There are three different status categories:
  - a. Red which means that the document is not in use.
  - b. Yellow which means that the document is a draft which is currently under development, so changes can occur.
  - c. Green which means that the document is the current applicable version.
- (v) **Publicised:** The input for this column is either 'Yes' or 'No'. If 'Yes', the document has been published and can be regarded as the governing document. If 'No' the document is a draft.
- (vi) **Approved version:** Used for keeping track of latest updates in terms of date for latest change and the current version number.

- (vii) **Remarks:** The column is used for document history and comments. Every entry in this column start with the date for the entry, e.g. '20/10/2022 The document title have been changed from x to y'.
